THIS APPLICATION MUST INCLUDE IN ADDITION TO THIS FORM:

1. PROOF OF OWNERSHIP OF THE VEHICLE TO BE PLACED IN SERVICE, INCLUDING PROOF OF 2 MILLION THIRD PARTY LIABILITY INSURANCE.
2. PROOF OF VALID PROVINCE OF ALBERTA REGISTRATION (LIVERY) CERTIFICATE AND COMPLIANCE WITH ALL REQUIREMENTS PRESCRIBED BY THE BYLAW.
3. AN OUT OF PROVINCE VEHICLE INSPECTION CERTIFICATE ISSUED BY A LICENSED MECHANIC AT AN APPROVED FACILITY.
4. COMPLETED AND PASSED BYLAW INSPECTION.
5. IF THE VEHICLE FOR HIRE IS A TAXI OR ACCESSIBLE TAXI, CONFIRMATION IN WRITING OF AN AFFILIATION WITH A MUNICIPALLY LICENSED BROKERAGE OPERATION UNLESS THE VEHICLE IS AN INDEPENDENT DRIVER OWNER.
6. IF THE VEHICLE FOR HIRE IS A LIMOUSINE, CONFIRMATION IN WRITING THAT THE APPLICANT HAS AN AGREEMENT WITH A MUNICIPALLY LICENSED BROKERAGE OPERATION TO PROVIDE BOOKING ARRANGEMENTS UNLESS THE VEHICLE IS AN INDEPENDENT DRIVER OWNER.
7. IF THE VEHICLE FOR HIRE IS A SHUTTLE, CONFIRMATION IN WRITING THAT THE APPLICANT HAS AN AGREEMENT WITH A MUNICIPALLY LICENSED BROKERAGE OPERATION TO PROVIDE THE FIXED ROUTE FOR THE MOTOR VEHICLE FOR WHICH THE VEHICLE FOR HIRE LICENSE WILL BE DISPLAYED.
8. CONFIRMATION THAT THE APPLICANT HAS A VALID CHAUFFEUR'S PERMIT OR A VALID BROKERAGE LICENSE OR A VALID INDEPENDENT OWNERS LICENSE.
9. COMPLETED FREEDOM OF INFORMATION AND PRIVACY NOTICE OF CONSENT (REVERSE OF THIS FORM).
10. RECEIPT SHOWING PAYMENT FOR VEHICLE FOR HIRE LICENSE (PER SCHEDULE J).
