The objective of the development program would be to enhance ringette skills including offensive goal scoring, shooting tactics, defensive skills and goalie training. These skills would be achieved by providing on ice training through skating drills and potentially off ice training and condition designed to enhance on ice performance. While Fort McMurray Ringette is blessed to have many parent volunteer coaches, there are very few coaches that have either played ringette or are experts in coaching ringette. Without these volunteers Fort McMurray Ringette would not be able to exist. Therefore is extremely beneficial for the local U10 Step 3 ringette team to receive funding to bring experts in ringette to help enhance the basis skills of the game taught by local coaches. This would enable our Fort McMurray team to compete competitively on the provincial level.

Experts would be able to provide enhanced ringette experience and guidance to our local coaches to enhance weekly practices. They would be able to provide expert advice to players and coaches to enhance skills and development

The U10 Step 3 recently travelled Oct 11-13 to St. Albert, Alberta for a ringette tournament. The tournament had multiple age divisions. Our local Fort McMurray Ringette U10 Step 3 played a total of 3 games, unfortunately the team lost all three games. It became obvious that even though our U10 step 3 team was tiered as U10 Step 3 by a universal assessment at the beginning of the season, the opposing team were much developed in areas of scoring tactics, offensive and defensive skills and goalie training. Our U10 step 3 team was beaten by Game 1 score 8-0, Game 2 score 14-1 and game 3 score 10-1. Evidently from the game score, there was a big discrepancy in game scores, despite being scored as according to the universal assessment. As a players parent, it was evident the opposing U10 Step 3 teams had enhanced scoring tactics, offensive & defensive and goal tending skills

The countless hours of time put in to engineering, design, and team work here at Westwood developed the skills our students needed for World success. Westwood Robotics attended the Fort McMurray Regional Tournament here in Wood Buffalo where the team showcased their ingenuity by securing 1st Place in the Region, alongside winning the Tournament Award of Excellence.

Due to this win Westwood Robotics was also invited to the Alberta Provincial Tournament as one of the very first qualifiers. This gave the team more time to prepare and tweak their design so their robot would be at peak competition level. At the event, the team was able to place 2nd in skills, ranking them 140th out of 11,000 teams world wide, 18th in Canada, and 2nd in Alberta. Due to their outstanding performance, they received an invite to attend the VEX Robotics World Championship in Dallas, Texas.

VEX Robotics is currently the world's largest robotics competition holder, one in which students in Westwood Robotics strive for success. 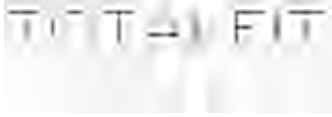

In the past, due to limited funding resources, cultural sports events such as archery were rarely organized. One such event was hosted long ago in the Métis community, sparking interest, but the lack of continuity left a gap in its development. With support from the Legacy Grant, the Archery Coaching Program will address this gap by promoting sports participation and physical wellness, specifically targeting youth in Fort Chipewyan. The program will hire a certified archery coach (tentatively from Fort McMurray) who will fly into the community to provide structured coaching sessions. We target to offer minor teams (or specifically the youth below 18) the chance to explore and learn cultural sports.

The 3-5 days Archery Coaching Camp (Date TBC) aims to provide professional archery training to 6-8 youth of all skill levels and ensure they receive quality instruction. It helps to foster life skills such as focus, discipline, and sportsmanship. Additionally, it will revitalize cultural traditions associated with archery, providing a recreational outlet while contributing to both physical and mental well-being. Furthermore, the program seeks to reconnect youth with traditional Métis hunting and archery practices, fostering cultural pride and awareness. It is also designed to encourage greater sports participation, promoting individual skill development and team-based collaboration. Through structured coaching and mentorship, the program will also lay the foundation for potential competitive archery, enabling participants to pursue opportunities at regional or national levels.

Besides, there is demonstrated interest in archery within the Fort Chipewyan community, as evidenced by the success of a past event hosted long ago. The lack of consistent funding has prevented the community from organizing similar activities in recent years. This program seeks to capitalize on the existing interest, providing a structured opportunity for youth to engage in a sport that holds both recreational and cultural value.

In each masterclass, the clinician listens to the student's performance then provides constructive comments. It is a priceless learning opportunity for both performer and observer. Students register two months ahead of the event and are scheduled for a segment of time with the clinician.

Students pay a small registration fee towards the expense of clinician fees. To keep registration fees affordable for families, the FMMTA relies on grants and partnerships to fund the facility rental and additional clinician costs, such as food and travel. Teachers volunteer their time to organize and run the event.

For our 2025 classes, we are in conversation with Obsidiana Duo: Pianist Yolanda Tapia and singer Camila Montefusco. They state their mission is "to celebrate the rich tapestry of Ibero-American musical culture and amplify the voices of historically overlooked composers."

These professionals will teach our masterclasses. We are also planning a community performance at the conclusion of our masterclasses.

We estimate registration from around 100 students. Students pay between \$20 - \$60 -- fees are based on the length of individual time they have with the clinician.

The objective of our project is to provide deeper music education to our students and their peers in the audience. Masterclasses broaden the knowledge and perspective of students, parents, and teachers. They are exposed to new techniques and skills. The event encourages students to engage with the community through music, and to pursue further study or careers.

Each student will perform on a stage with a grand piano, which is a rare opportunity for most students.

The clinician is a different teacher from their own, and can provide a unique perspective and feedback for the student. Students and parents leave masterclasses with smiles and renewed motivation to study and practice.

Last year students were in awe of the skill and expertise of their clinicians, especially with the chance to see them perform. For many, that was their first time seeing classical music performed live, and spoke of it with their teachers for many weeks afterward.

Under strict rules and with limited resources, teams build and program robots to perform complex tasks against a field of competitors. Throughout the season, students develop technical skills as well as problem solving, teamwork, and communication skills. Regional and Provincial tournaments provide opportunities for participants to develop leadership skills, be part of a provincial and international community, and learn about how other students tackle robotics problems. This is preparing our students to be productive contributors to our community and local economy. Many of these students are leaders in the school and in the community.
