

# 2024 Snow Angels Contest – Contest Rules

The following are the rules (“Rules”) for the Snow Angels Snowblower Giveaway (the “Giveaway”) being administered by the Regional Municipality of Wood Buffalo (“RMWB”).

## 1. ELIGIBILITY

To be eligible for the Giveaway, entrants must be legal residents of the Regional Municipality of Wood Buffalo and be eighteen years old or older at the time of entry. Employees and elected officials of RMWB and their immediate family and household members are not eligible to participate in the Giveaway.

## 2. HOW TO ENTER

**NO PURCHASE NECESSARY.** To enter, entrants must register to volunteer with the Snow Angels Program, commit to clearing snow for winter 2024/2025 at an assigned, qualified residence. Must be registered with the Snow Angels program AND assigned a qualified residence by 4:30 p.m. on December 15, 2024, after which time no further entries will be considered. Only one entry per person will be considered.

## 3. SELECTION OF WINNER

Upon completion of the Giveaway, a RMWB representative shall review the entries submitted and choose a winner at random. The potential winner will be contacted by email on Tuesday, April 23, 2025 at approximately 6 p.m. and will have four hours to respond and provide their contact information. If a selected potential winner does not respond in the allotted time, another potential winner may be selected at RMWB’s sole discretion.

## 4. PRIZE

There is one Prize available to be won. The Prize is a Two Stage, 24 Inch, Gas Snowblower with Electric Start. The approximate value of the prize is one thousand dollars (CDN\$1,000). The Prize is not redeemable for cash and must be accepted as offered without substitution. The odds of winning the Prize depend on the total number of eligible entries received.

## 5. RELEASE

The Winner will be required to execute a Winner release form (“Release”) that confirms Winner’s: (i) eligibility for the Giveaway; (ii) acceptance of the Prize as offered; (iii) release of RMWB, its employees, and elected officials from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Giveaway or the acceptance, use, or misuse of the



Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property. The executed Release along with the correct answer to the skill testing question must be returned within five (5) business days of the date of verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

## 6. GENERAL

By participating in the Giveaway, you agree to abide by these Rules and the decisions of RMWB which shall be final and binding in all respects. Entrants who have not complied with these Rules are subject to disqualification.

Notwithstanding the defined Giveaway Period, RMWB reserves the right, in its sole discretion, to terminate the Giveaway, in whole or part, and/or modify, amend or suspend the Giveaway, and/or these Rules in any way, at any time, for any reason without prior notice.
