BYLAW NO. 18/010

BEING A BYLAW OF THE REGIONAL MUNICIPALITY OF WOOD BUFFALO TO AMEND THE LAND USE BYLAW NO. 99/059

WHEREAS sections 191(1) and 639 of the *Municipal Government Act* empower a council both to pass and to amend a land use bylaw;

NOW THEREFORE, the Council of the Regional Municipality of Wood Buffalo, in the Province of Alberta, hereby enacts as follows:

- 1. Land Use Bylaw No. 99/059 is amended.
- 2. Section 143.6 is deleted and replaced with the following:
 - 143.6 A billboard sign shall be located within a minimum distance of 300.0m from any other billboard sign on the same side of the road.
- 3. Appendix B Sign Districts Chart: Rural Service Area to Part 7B of the Land Use Bylaw is deleted and replaced with following:
