The aim of the Cutting Edge Development Camp is to bring highly skilled ringette players to Fort McMurray to assist in team development in the Fort McMurray Ringette U10 Step 3 players. At the U10 level there is a transition from playing on a half ice surface to the full ice. The Cutting Edge Ringette Academy Development Camp offers highly skilled & knowledgeable Ringette instructors to assist the team in teaching fundamental ringette skills to improve the players knowledge & skills of the Ringette game.

The U10 Step 3 team just completed in the Turkey Ring Ringette Tournament Oct 10-Oct 12 in St. Alberta. Our team played 3 games and unfortunately lost all three games. Game 1 was against Fort Saskatchewan Ringette, we lost 9-2. Game 2 was against St. Albert Ringette team 1, Fort McMurray lost 6-0 and our 3rd game was against St. Albert Ringette Team 2 we lost 7-1. It was evident the skills level of the other teams was higher compared to our Fort McMurray Team in the same U10 category. Our U10 Step 3 team has 3 on ice coaches, 2 of them have played hockey and the other coach has previously coached however none of them have played ringette and are learning the ringette game as they go. The Cutting Edge development Camp would help enhance shooting, skating and game sense to allow the U10 Step 3 to compete at a level comparable to their peers and also bring development skills to our team coaches.
