Brief Summary of the Proposed Program(s) and/or Project(s).

The Cadet program is a national program for all Canadians aged 12 to 18 who are interested in participating in a variety of fun, challenging and rewarding activities. These activities will encourage and help develop fitness, leadership skills, citizenship and well-being. The Air Cadet program is aviation focused and aims to help youth improve their knowledge of aerospace and aviation by supporting and providing access to educational programs and resources. It also prepares youth to become better engaged citizens by providing access to educational programs and resources including leadership, communication, volunteer opportunities and awards and scholarships. Many cadets are high achieving students who go on to be future leaders. Through the program the cadets gain real world experience in guiding others and building community.

The Cadet Program at its best - youth leading youth and readiness built through responsibility.

Signed in June 2020, the Canadian Armed Forces "Memorandum of Understanding" outlines the Squadron Sponsoring Committee's responsibilities.. These include the provision of financial support for facilities, materials, transportation and other costs of supporting the Squadron when not provided by the Canadian Armed Forces. Their financial support is limited and does not cover all of the Squadron's operational expenses. Our remote location does not have the advantage of access to military premises, which places a burden on the Committee to fund a suitable location for training a growing Squadron.

What efforts have been made in the past fiscal year to increase the financial support for your organization?

Fiscal responsibility remains a top priority for the Squadron Sponsoring Committee ("SSC"). Oversight of finances and the operating costs of the Squadron is undertaken by the SSC, which is comprised of volunteer unpaid cadet parents and assisted by other unpaid parent volunteers.

There are only a few activities each year that are funded by the Department of National Defence ("DND") and these are being reduced due to their own decreased budget. Given our remote geographical location, with no local military base for support, our costs to travel for out of town activities have increased. Like any other local organizations we are challenged by the high cost of facility rental. The DND are unable to provide any additional support with this.

This leaves the SSC to raise funds to bridge the gap. In addition to seeking continued support from our Title Sponsors, we fundraise throughout each year, including cash calendar sales, volunteering at the Royal Canadian Legion (poppy sales and bingo), volunteer shifts at the Casino and other fundraising activities. There are limited opportunities for the Cadets to fundraise themselves, due to restrictions imposed by the Canadian Armed Forces.

The Squadron will accept any youth between the ages of 12 and 18 and is multiculturally diverse. Cadets from all socio-economic backgrounds have benefitted from a judgment free educational and skills development program which requires them to accept personal responsibility for their own actions and by doing so a high number of Cadets have been able to qualify for the most attractive rewards the Program offers. The Cadets have earned these rewards through merit and good service by meeting established training and behavioural standards and by participating in a progressive training program featuring both compulsory and optional elements.

To keep the Program cost free for the Cadets, the Squadron Sponsoring Committee helps raise the income needed to meet the costs that cannot be paid by the Department of National Defence. These include facility rental costs, transportation and meals for regional events such as gliding weekends, survival training, Biathlon/Effective Speaking/Drill Competitions plus optional activities that are not covered by the Department of National Defence. The Committee also covers the cost of administrative supplies (computers, printers etc), insurance policies and utilities.

Statement of Need: What social problem or gap do you hope to address by delivering the program, project, service or event? What evidence do you have that this problem or gap exists?

There are many families in our region who are prevented from accessing competitive sports and other activities because of the high cost of membership and equipment. As a no-cost program, Air Cadets helps to fill gaps through its no-cost access to extra curricular activity with an emphasis on aviation/STEM education, leadership, personal development, physical fitness and well-being, teamwork and community engagement. The program promotes cultural and social integration and encourages the Cadets to provide positive role models and mentorship to the new cadets who join each year. The Squadron has shown consistent growth year on year as demand increases for such an attractive program.

Broad Strategy: How will the program, project, service or event address the social problem? (e.g., What approach are you taking that you hope will lead your program, project, service or event to support the social problem?)

The Air Cadet program provides a structured environment where youth can improve their quality of life by developing leadership skills, self confidence, discipline and responsibility. The Program provides opportunities for youth to explore careers in aviation, aerospace and other sciences. It also places a strong emphasis on physical health and fitness. Cadets participate in sports, drills and other activities that promote a healthy lifestyle, which helps address gaps in physical education. The program also promotes community service, volunteerism and civic responsibility.

The Program also provides access to positive adult role models and mentors. Officers, Civilian Instructors and Senior Cadets offer guidance and support that can positively influence the lives of all Cadets.

The Program brings together youth from various cultural, ethnic and socio-economic backgrounds, promoting inclusivity, collaboration and mutual respect.

Enrolment in the Air Cadet Program is increasing year on year. Cadets are engaged and motivated in the program. They go on to seek out careers in aviation and the military. As Cadets progress through the program and gain promotion, we observe the improvement in their skills, knowledge and abilities. Senior Cadets will step into leadership roles and mentor new and junior cadets, who aspire for promotion.

Inputs: What resources will be invested to achieve your goal? (e.g., staff labour, venue space, volunteers, computers, etc.)

Officers and Civilian Instructors run the activities, training and programs in accordance with the defined National Training Program. The Squadron receives a fixed allowance from the Department of National Defence.

The Squadron Sponsoring Committee helps raise the income needed for those expenses that cannot be paid by the Department of National Defence. The include facility rental costs, transportation and meals for regional events such as gliding weekends, survival training, Biathlon/Effective Speaking/Drill Competitions plus optional activities that are not covered by the Department of National Defence. The Committee also covers the cost of administrative supplies (computers, printers etc), insurance policies and utilities.

It is the role of the Committee to provide the resources needed for operational activities that enhance the retention of serving cadets and attract new recruits to the Squadron.

There are weekly regular training nights on subjects including aviation, leadership, Drill, dress and deportment, time management, citizenship, teamwork and accountability. There are also sessions on like skills development through PHASE (Promote Health And Safe Experiences) training.

On two additional evenings per week, Cadets can choose to participate in enhanced training sessions in Marksmanship, Biathlon, Band, Competition Drill Team and Public Speaking. They can compete at a local, Provincial and National Level - this Squadron's Competitive Drill Team has won the Provincial Competition for the last two years.

At least twice a year there are Field Training Exercises which cover lifesaving skills, survival and wilderness training, teamwork and responsibility.

At least once a year the Squadron aims to participate in a gliding weekend or motorized familiarization flights.

The Squadron parades as part of the annual Remembrance Day ceremonies in Fort McMurray.

The Squadron trains over 100 cadets each year with the aim of preparing youth to become better engaged citizens by providing access to educational programs and awards and scholarships. Many cadets are high achieving students who go on to be future leaders. Through the program the cadets gain real world experience in guiding others and building community. We have a high level of retention as Cadets strive for promotion and selection for national summer camps in specialized skills such as marksmanship, outdoor survival and aviation.

The Program is a free extracurricular activity for all youth between the ages of 12 and 18. There are no cultural or religious barriers and the uniform has been changed to allow for inclusion of items of cultural or indigenous significance.

The military traditions and the structure of the organization makes the Air Cadets different from Scouts Canada or Girl Guides. The direct focus on aviation is the greatest difference between the Air Cadets and the Army Cadets who also operate within the community.
